

With the proliferation of art programs in the Lansing area, the league was instrumental in the formation of the Lansing Fine Arts Coordinating Committee that later became, with our League's assistance, the Fine Arts Council which still stands today. Junior League Active Member **Leslie Donaldson** currently serves as the Arts Council Executive Director. I was ED of the Arts Council for over 23 years and I have always been proud to know that it got its beginnings with our League. The Cedar Chest continued as a provider of quality clothing to the community while serving as a major source of income for the League. League also produced two Follies in the 60's to raise additional funds for community projects.

The N/P Committee placement process uses a points system, which the advising team has been tracking and recording for each Active Member throughout the year.
