STATE PUBLIC AFFAIRS COMMITTEE

The State Public Affairs Committee (SPAC) of the Michigan Junior Leagues is dedicated to empowering members throughout the state to use their voice to enact real policy change at the local and statewide levels.

Thank you to everyone who joined us for Day at the Capitol 2016! We had a record turnout for our League, and we look forward to an even more successful year to come. Dayt at the Capitol is an information-packed day with informative speakers, networking with women from Leagues across Michigan, and advocating with our local legislators in support of our key issue areas: foster care and human trafficking.

Over 14,000 children in Michigan are currently in the foster care system and the Michigan State Council (MSC) SPAC is committed to improving the lives of foster children, encouraging others and making it easier to foster children, and doing our best to empower and encourage birth parents to be reunited with their child in a happy and healthy environment.

In order to do that, we are focused on 6 key foster care areas in the short and long term:

- 1. Digitize and merge children's medical and mental health records
- 2. Reimburse daycare on a dailynot hourly basis
- 3. Ensure foster parents are receiving the proper tax incentives
- 4. Provide basic services to foster children in a timely manner
- 5. Standardize early intervention services for foster children
- 6. Expand on foster care identity theft protections

Human trafficking continues to be one of our top priorities. This works well with our focus on foster care because victims are generally more vulnerable women and men, many of whom are in or coming out of the foster care system. Most recently, the Human Trafficking Notification Act was passed, requiring public places including adult entertainment facilities to post contact information for the the National Human Trafficking Resource Center Hotline. MSC SPAC testified at hearings before the state legislature in support of this important measure.

The State Public Affairs Committee continues to be supported by our lobbying firm, Capitol Services. For over 20 years, Capitol Services has worked with Junior Leagues across the state to empower members to advocate on behalf of our issues. With their help, we have a great track record of getting results that have a true impact on the lives of Michiganders.

Thank you to everyone who has added your voice to these important issues. Whether it's attending Day at the Capitol or simply lending your voice online, your activism has made a difference! 85 YEARS OF SERVICE TO LANSING

Our new year, 2016-2017, I leave here with you these officially welcomes in our 85th year of service to the Lansing community! Who wrote a document titled

All that we have done and accomplished over the past 84 years {immediate relief grants to hundreds of area organizations - scholarships - countless children's programs - health clinics - those beautiful bronze giraffes still standing tall at Potter Park Zoo - and so much more} would not have been possible without all of the amazing women that came before us.

Each and every member over the past 85 years is a remarkable woman in her own right - smart, talented, visionary. Each leaving a piece of her heart with this organization. There have been times over each member's Active years where she's given so much to League that her home, her job, her family have come second. That is why we are still here. Still serving our community. Our members want to do everything they can to make Lansing a better place. Because it's our place, our community, our home and every single one of us has made a commitment to make it the best it can be. The Junior League of Lansing is our Legacy.

The work we do over the next few years will complete our first century of service. Honor this amazing feat for an organization made up completely of volunteers - to be looking forward to our second century of service to improving our community.

I leave here with you these words from an unidentified Sustainer who wrote a document titled "Founding and Early History of Lansing Junior League" that is on file in our office archives (a copy has been posted online for our Members who would like to read it in it's entirety) - I believe it was written for an incoming New Member class sometime in the early 1950s:

"In the Spring of 1931, three young Lansing women, sparked by the energetic Vera Eddins, ... met to discuss Lansing's lack of a women's service organization -- in particular, a Junior League. As the daughter of a General Motors Executive, Vera had lived in many places and was well aware of the advantage a membership in Junior League could mean to a young woman. Being very community minded, she had the vision to see the potential of a Junior League in fast growing Lansing. With the help of Ruth Shumway and Betty Coleman, both lifelong residents, a nucleus of 18 young women were gathered together to bring into being the Lansing Junior Service League. Through the cooperation of the Association of Junior Leagues of America we had been provided with the framework for a workable set of by-laws; and more important, permission to use the name Junior Service League. There was of course no hint as to whether the Lansing group would ever be eligible for membership in A.J.L.A.

I'm sure your sociology courses are still fresh enough in your young minds that you recall the 1930's as memorable for some of the worst depression years our country has known. The need for our type of Volunteer Service was great.

In early years one attempt was made to become a part of A.J.L.A. [A]LI], but our town as well as our membership was too small, our achievements unproved. But in September of 1948 our seventeen year dream came true as we became a member of the wonderful family of Junior Leagues of America. ... At the time we affiliated with the A.J.L.A. the members who had become Sustaining at the mandatory age, took an intensive training course along with the actives ... This large Sustaining Group continues its great interest and support of the League as they have gone on to fill hundreds of important positions in our ever expanding community.

I hope these reminiscences of an old Sustainer have given you just a little bit of the spirit of the League, whose ever forward looking enthusiasm has contributed so much to a better community for all of us. I envy you all as you start on what I know will be one of the most gratifying and enriching experiences of your lives. Go to it."

Several families from the Greater Lansing Area came out to participate in a variety of activities centered around healthy lifestyle habits. Organized by this year's new member class, Kids in the Kitchen featured Lettuce Live Well, Chef Cecilia Garcia, Sugarbusters, interactive hula hoop and zumba demonstrations as well as a visit from Sparty! Lettuce Live Well enabled children to imagine what a healthy meal of their choice would look like by guiding them to draw meals exemplifying proper serving sizes. Chef Cecilia Garcia demonstrated live crockpot cooking. Participants enjoyed both the blueberry oatmeal and tacos onsite before taking the recipes home to enjoy again. Sugarbusters used visual aids to show families how much sugar popular beverages like Powerade and Coke actually contain. Participants

also enjoyed other hands on activities including a yogurt parfait station, a DIY trail mix station and a garden demo where children planted their own green bean seeds. Kids in the Kitchen not only provided an opportunity to help prevent childhood obesity in the Lansing area through fun interactive learning but it was also an opportunity for the Junior League of Lansing to engage directly with our community which made this event a great success.



A YEAR IN NUMBERS

The Junior League of Lansing fiscal year 2016-2017 was a financial success! Through managing our expenses and an outstanding fundraising effort, not to mention a very generous contribution from the Endowment Fund, we were able to meet and exceed our goals.

For 2016 we obtained approximately \$32,200 from dues. Dues were paid by 121 actives and 260 sustainers. This was an improvement over the prior year total dues collected of \$31,800. Dues represented approximately 28% of our revenue to date.

Our Fundraising efforts remained strong and improved from the prior year, up to approximately \$42,000! The Signature Fundraiser collected \$15,232 and Lunch with League brought in \$15,459. For the second year in a row, the High Heels & High Tea was a major success, raising approximately \$11,375 (which includes a \$5,000 donation from Walmart). Fundraising represents approximately 36% of total revenue to date.

Other revenue raised consists mainly of the transfer from the Endowment Fund, which increased from \$27,684 in the prior year to \$28,647 for the 2016-2017 year. A huge thanks to the Endowment board, and those of you that have donated to the Endowment Fund. Without continued funding of the Endowment, League would be without a significant source of revenue to fund our budget.

Taking a look at expenses, our Community Project related expenses including Community Outreach, Legacy Sponsorship, Done in a Day Projects, Community Response Grant, Community Impact Grant, and Kids in the Kitchen increased from approximately \$20,000 in the prior year to approximately \$25,000 for 2016-2017. We are happy to note that a community impact grant was approved this year, which is the main reason for the increase in expense within this category.


Our Fund Development council did an excellent job managing expenses for our fundraising efforts, and kept expenses consistent to the prior year, around \$10,000. Project expenses, including new member recruitment, SPAC dues, and AJLI dues did increase from the prior year, from approximately \$13,200 to approximately \$14,400. With a large new member class, and an increase in the number of active members paying dues, these expenses increased accordingly.

Finance Council would like to give a special thanks to all actives and sustainers who helped make this year a financial success. Thank you for paying dues timely, submitting appropriate check requests and monitoring the budget!

Press the name of the person you are looking for and their detailed information will appear. (The alphabetized member roster is combined sustainers and actives.) If you press the envelope icon on an individual's site you access their email address. The best part is you may update or add personal information at your convenience. For those who use smart phones, this is a very handy alternative.

Please think of our JLL Endowment when honoring a friend or family member. Remember birthdays, anniversaries, new babies, job promotions, teacher gifts, or in memoriam. Think of ways to acknowledge members for their league work as well. You may donate via check or do so on our JLL website.
